Objectives and investment policy

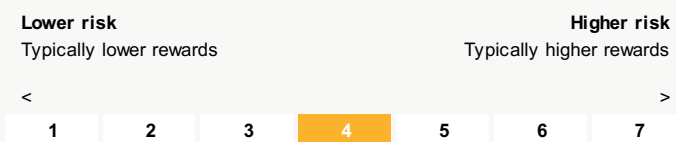
The Sub-Fund is passive and has the objective to track the performance of the iTraxx European Crossover Credit Short Index (the Index).

- The Sub-Fund aims to invest as far as possible in the fixed income exposures (such as through bonds and derivatives on CDS index) that make up the Index. The Sub-Fund’s ultimate exposure will be to a diversified short portfolio of European high yield corporate credit.
- The Index is calculated using the value of a hypothetical portfolio composed of the iTraxx Crossover (ITRX XOVER) 5 years CDS index with the remaining cash component receiving interest at the EONIA minus a spread (subject to change). The Index is rebalanced monthly to maintain an approximate 1:1 short market exposure. The Index rebalances the CDS based on a ratio of notional times CDS bond equivalent price to Index value, so the notional to Net Asset Value ratio may differ from 1:1. The CDS index position held is rolled to the latest issued series when the new series becomes available semi-annually. Transaction costs are included in the Index.

- The Sub-Fund aims to replicate the Index via holding a short CDS index position. The Sub-Fund will also seek to replicate the cash component return of the Index by investing its cash holdings in cash deposits, cash held with a custodian, short term debt securities, bonds that may be fixed or floating rate, certificates of deposit, bankers acceptances and money market instruments (such as short-term government bonds).
- The Share Class of the Sub-Fund will accumulate income in their value.
- This Sub-Fund may not be appropriate for long-term investment.
- The Share Class is denominated in Euro, the Sub-Fund’s base currency.
- In normal conditions, Authorised Participants may deal in shares directly with the Sub-Fund. Other investors can deal in shares daily through an intermediary on stock exchanges on which the shares are traded.

Risk and reward profile

The Share Class is rated 4 due to the nature of its investments and the frequency of price movement which include the following risks which may impact the value of the Share Class or expose it to losses.

- No capital protection: The value of your investment may go down as well as up and you may not get back the amount you invested.
- Market risk: The Sub-Fund is primarily exposed to short credit risk. Returns will increase if there is a default, or higher perceived risk of default, among the entities referenced by the CDS indices, or a write-down (“bail in”) of an entity’s debt by financial authorities. The Sub-Fund may also be impacted by other factors affecting the value of debt securities issued by those entities, including changes in interest rates and exchange rates. When buying CDS on subordinate debt, such debt may be subordinate to senior debt.

- Short exposure risk: The Sub-Fund uses a short market exposure to the underlying market with rebalancing on a monthly basis. The performance of the Sub-Fund over periods longer than one month may not be inversely proportional or symmetrical with the returns of long positions in the underlying instruments. The assumed return on cash in the index also contributes to asymmetry in returns versus a long position. The Sub-Fund is intended for investors who wish to take a short-term view on the Index and whose investments are not intended as buy and hold.

- Leverage: The Sub-Fund may use leverage, so losses may be magnified.

- Liquidity risk: Lower liquidity means there are insufficient buyers or sellers to allow the Sub-Fund to sell or buy investments readily. Neither the Index provider nor the issuer make any representation or forecast on the liquidity of CDS transactions.

- Counterparty risk: The Sub-Fund may incur losses if any institution providing services such as safekeeping of assets or acting as a derivatives counterparty becomes insolvent.

- Credit Risk: The issuer of a financial asset held within the Fund may not pay income or repay capital to the Sub-Fund when due.

Ongoing charges have not been based on an ex-post calculation as the Sub-Fund was launched less than one calendar year ago. Ongoing charges have accordingly been estimated based on the expected total of charges that will be taken from the assets of the Sub-Fund over the course of a year, in accordance with the Sub-Fund's supplement. The ongoing charges figure is based on expenses for the financial year ending 30th June 2019. This figure may vary from year to year. It excludes portfolio transaction costs and taxes or duty charges for portfolio re-balancing, except in the case of an entry/exit charge paid by the UCITS when buying or selling units in another collective investment undertaking if any.
